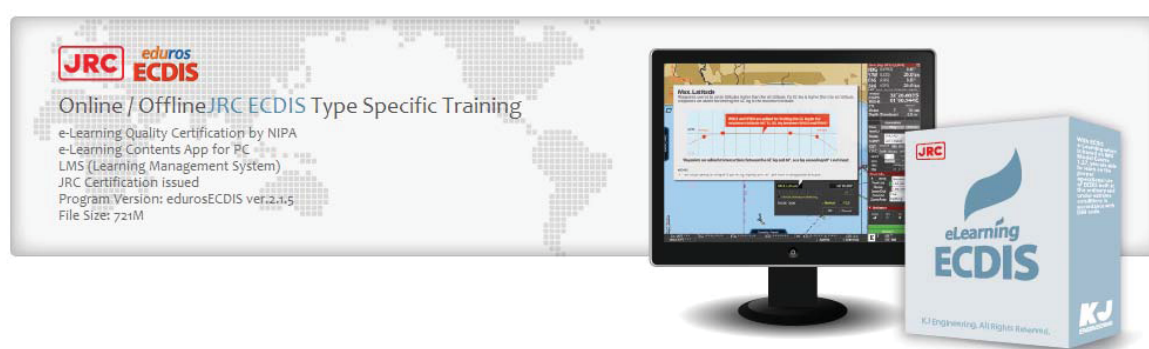


III. Overview

1. Overview

The edurosECDIS JAN-9201, JAN-7201 is a JRC ECDIS e-learning module for JRC ECDIS models, JAN-9201 and JAN-7201..

It is comprised of CBT(Computer based Training) & WBT(Web Based Training) together with web-based LCMS (Learning and Contents Management System) and is intended to educate and train all bridge officers on vessels which have JRC ECDIS as the primary means of navigation by introducing the officers how to learn on the proper operational use of JRC ECDIS both at the ordinary and under extreme conditions

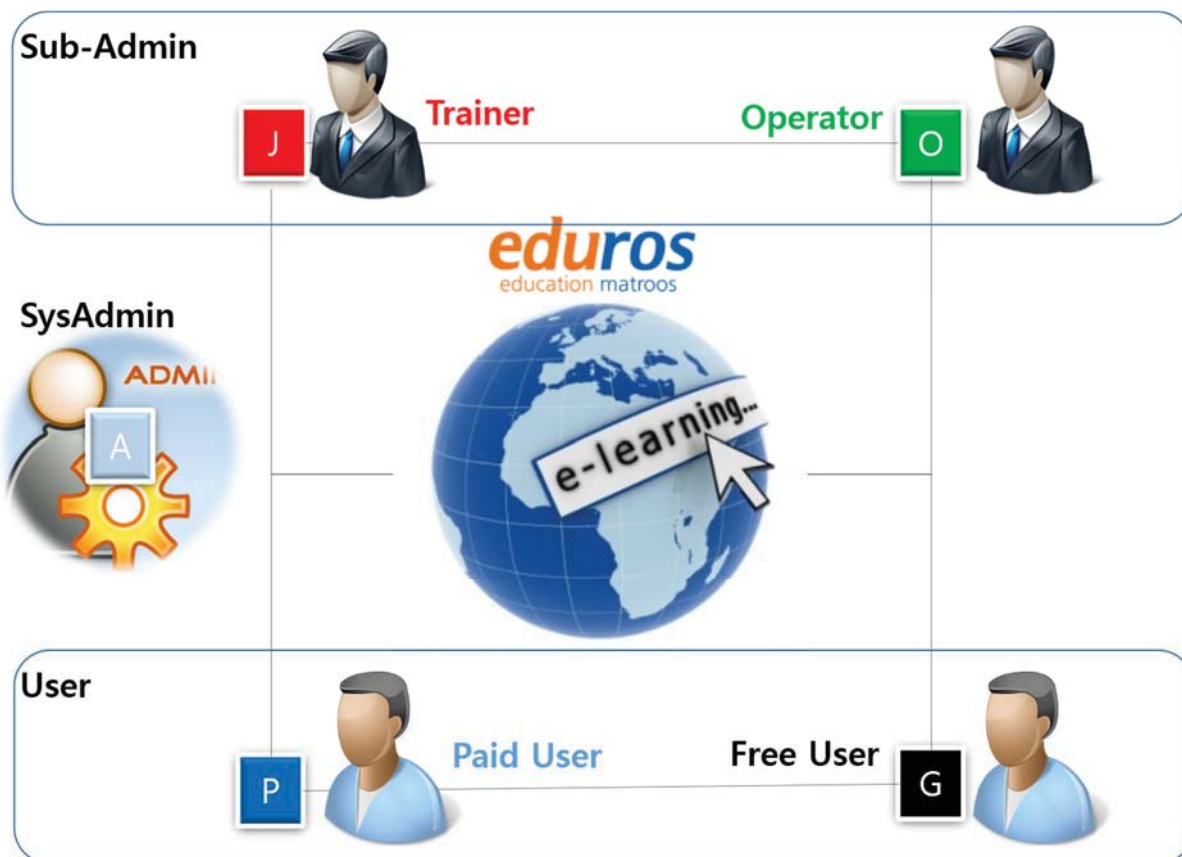

The Web enhanced LCMS(Learning Contents Management System) is provided to administrators who can handle all aspects of the learning process for administration, documentation, tracking and reporting of e-learning courses by incorporating the "synchronous or asynchronous Internet communication technology" into the system which serves to "facilitate a simultaneous independent and collaborative learning experience

10. Type of Users

There are five types of users in three tiers, System administrator, Sub-Admin tier, “Trainer and Operator” and User tier, Paid or Free User, They are classified depending on the services, different authorities and roles they are entitled to,



-  General user is a free account who is allowed to gain access to the limited lessons for trials only
-  Premium user is a Paid account who could get access to all services.
-  Trainer is authorized by JRC as a JRC ECDIS Type Specific Trainer on behalf of JRC, who could set up a class and course for users, monitor their learning process throughout the courses and verify the candidate who apply for the verification at the time of the interview
-  Operator is a group manager who could can add group member to the group, supervise the user’s leaning process throughout the courses, set up an interview date or upload a G/Letter for his group member.
-  Administrator, or sysadmin, is a person who is responsible for the upkeep, configuration, and reliable operation of edurosECDIS JAN-9201, JAN-7201 systems



IV. Course Procedure

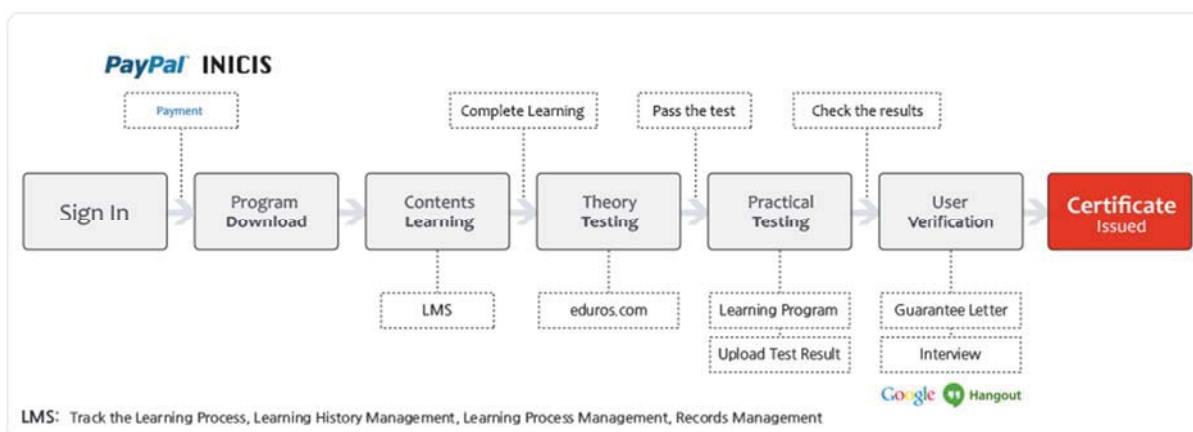
1. Course Outline

The edurosECDIS JAN-9201, JAN-7201 is a JRC ECDIS Type Specific e-learning Course on JRC ECDIS JAN-9201 and JAN-7201 which is in compliance with Manila Amendments to the STCW which require that the seafarers take type-specific familiarization training for the JRC ECDIS system installed on-board the vessel

This course is intended to educate and train all bridge officers on vessels which have JRC ECDIS as the primary means of navigation by introducing the officers how to learn on the proper operational use of JRC ECDIS both at the ordinary and under extreme conditions

Here is an introduction to the course which has eight(8) following Steps in three(3) Language

2. Sign Up with Group code

if you are the first time user for edurosECDIS, you will need to create an account for the service. Online registration is usually accomplished with the eduros site (www.eduros.com) while Offline is done via the phone, fax and email. You can use any email address as the user name for the service. If you do not specify any group at the Sign up phase, The eduros group is assigned automatically as a default for the overall management of your course.

You must start courses from the date when you're required to register

3. Log In

You can log in to the eduros site (www.eduros.com) with your email address and password you registered.

4. Payment

If you already have a PayPal account, enter your password and click Log In the paypal site. (<https://www.paypal.com>), Otherwise, you can enter your personal information in order to make a payment to paypal without a paypal account.

5. Download

Once the payment is completed, it is redirected towards the page for online user where you can download the programs which you bought and install them on your PC, or you can also download the

program in 'My Learning' page afterwards. In case of offline users, the programs can be delivered on CD-ROM or USB, where a trainee can access to all courses without online connections.

6. Installation

Each user may install and use one copy of the software product on up to three computers for its sole use provided that only one computer is in use at any given time. This includes home and work, or a laptop and desktop

7. CBT (Computer Based Training)

- ① CBT lessons - The CBT lessons would be covered in following 11 sections including self-practices and the final written test for total running time in 04h 41m 47s, where the CBT takes the trainees through each courses and practices. However, the actual course will statistically take more twice than that, and also it depends much on the trainee's knowledge and experience in the JRC ECDIS

- Ten (10) CBT lessons

- Five (5) Practical Guides and Tests
 - The Final Test,
- ② Practical Guide & Test - Evaluation comes with two practical modes, practical guide and test and it is to be carried out in five (5) stages in between the courses and the test. Upon completion of the first three lessons, you can go into this mode for the first (1) evaluation. The purpose of guide is to provide a basic line again to the trainees over the lessons they have learned, and the purpose of test is to see what they actually understand and to meet the JRC TST standards for those lessons they have learned.
- if the trainees failed the test three times in a row, the CBT automatically guide them to all the contents directly associated with the tests, after completing the lessons, they are given another chances for the test again. if failed another three more chances again, they are brought back into where they started for the same lessons again & again until they fully understand such subjects and pass the test.
- ③ The Final Test – After completing the above ten (10) courses and five (5) practical tests. You come at the final written test. if you make 70% or more scores within three chances, you are entitled to go to the next stage for ID verification, Otherwise you must re-take the test with another three chances after paying re-exam fee of US \$ 150

8. Verification

When you pass the test, you will reach the final step to ensure the identity of yourself. There are two types of verification process available “Interview or Guarantee Letter, any of which can be selected depend on your situations

9. Certification

If your identity is finally confirmed at the verification stage above, The Certificate will be issued automatically by e-mail to your company within 24 hours after the verification.

10. Learning Evaluation

A series of questions in a training evaluation is distributed to you as a way to evaluate the given course after completions, It gives the learners the opportunity to provide feedback to us so than we can analyse and interpret all the valuable information for quality of instruction as well as accurate measures of teaching effectiveness

1. Computer Based Training (CBT)

A eduros CBT is a new-age way of e-learning in a form of blended learning for seafarers at sea, which is based on asynchronous offline messaging technology and a new synchronization algorithm that allows for a user to send a message to someone who is offline and updates the file when the offline user comes back online

The updates sync to the local drive of computers and to your cloud account in the Server at the same time; thus you can instantly access the latest version of your files locally, via web browser, and using mobile apps too.

- reduces the time and bandwidth needed to identify differences between the local cache and the server
- determines which parts of a file in the local cache have changed, and then updates only those parts of the file on the server.

The CBT program is installed on the PC by an Online (Download) or Offline process (DVD/USB), and most of training is executed on your own between the online and offline mode depending on the network situations where you are .

At the completion of the course, trainees must take the final written test. Then they upload the test result files on the server or email them to their trainer for evaluations.

According to the result, The Certificate will be issued automatically by e-mail to your company or to you

2. Web Based Training (WBT)

This is a subset of CBTs in which the material is made accessible on the Internet by applying Web technologies. Typically, The WBT is also referred to as "online courses" and "Web-based Training"

Trainee learns the course using web browser to log in the training application consisting of training material, evaluation tool and learning management function, which is placed on the web server (Training application will not be installed in the PC of each trainee.)

At the completion of the course, trainee must take an assessment test using tool of the training application. Trainee submits a successful result of the test with a guarantee letter which the administrator of the trainee prepares to JRC by e-mail or on the web. If it satisfies a requirement, JRC issues a certificate (hard copy) to the trainee

- The WBT can be delivered anywhere in the world where the Internet is available
- Multi-platform capabilities are possible, such as Windows, Mac, UNIX, PDA, phone, among others
- Content can be easily updated
- Access can be controlled
